 Proposed Submission of the 2016 Action Plan
 U. S. Department of Housing and Urban Development

Notice is hereby given by the city of Charleston that a proposed Annual Action Plan is being drafted. This notice references the project list that has been recommended for inclusion in the city's Annual Action Plan for Program Year 2016. The Mayor's Office of Economic and Community Development (MOECD) intends to submit this Plan for \$1,364,869 in U.S. Department of Housing & Urban Development (HUD) Community Development Block Grant (CDBG) funds and \$473,094 in HUD HOME Consortium (Charleston-Kanawha County Consortium) funds. The Annual Action Plan will be submitted to the U.S. Department of Housing and Urban Development on or before May 15, 2016. In accordance with the Final Rule for revised program regulations, 24 CFR, Part 91, et al, the city of Charleston is required to prepare and submit an Annual Action Plan for its Housing and Community Development programs.

In order to obtain the views of citizens, public agencies and other interested parties, the city of Charleston has placed its proposed FY 2016 Annual Action Plan, including the proposed project list for 2016, on display from March 14, 2016 through April 13, 2016 on its website www.cityofcharleston.org and at the following locations during normal operational hours:

The proposed Annual Action Plan will be available for review for 30 days.

II. HOME Investment Partnership.....\$473,094

Funds will be allocated to qualified homebuyers, non-profit organizations and Community Housing Development Organizations (CHDO's) in Charleston and Kanawha County, and to administer the programs.

NOTE: All of the above listed activities and funding levels are proposed and are subject to change based on Charleston City Council and HUD approval, public comments, Congressional rescission and total funding availability, or other unforeseen circumstances.
